Summary of Meeting

Nomination of Chair Pro-Tempore

Chair Raschko and Vice-Chair Candler were absent from the meeting. Long Range Planner Jenn Rogers led the Planning Commission through nominating a Chair Pro-Tempore for the evening. Commissioner Hughes nominated Commissioner Mitchell for Chair Pro-Tempore. The motion was seconded by Commissioner Woodmansee. There was no discussion and the motion passed unanimously.

Approval of Minutes (10/11/2022)

Work Session: 2022 Docket Staff Report

Long Range Planner Jenn Rogers discussed the docketing process and gave an overview of the 2022 docket petitions along with recommendations from staff. The items discussed were:

- LR22-01 Small Scale Recreation & Tourism Rezone
- C22-1 Wind Turbine Use Amendment
- C22-2 Critical Areas Ordinance Correction
- C22-3 Guemes Island Overlay Side Setback Amendment
- C22-4 Economic Development Plan Amendment
- C22-5 Seawater Intrusion Areas Amendment

Work Session: Annual Capital Facilities Plan Update and Transportation Improvement Program Forrest Jones with the Skagit County Public Works Department provided an overview of the updates to the Transportation Improvement Program. Long Range Planning Manager Sarah Ruether then presented on the annual changes to the County's Capital Facilities Plan. Ms. Ruether explained that this year's update is limited to county-managed facilities and went over some of the biggest changes for the 2023-2028 Capital Facility Plan. A public hearing will take place November 8th and deliberations will occur on November 22nd.

Director's Update

Director Hal Hart gave a brief update on the work the Department is doing with FEMA to improve resiliency in Skagit County. Staff are collecting the data necessary to create a tool to help people better understand the risk factors in Skagit and how to prepare themselves from future climate events. Director Hart then discussed the status of various housing and commercial projects in the County.
