#### Summary of decision points and key agreements:

- Importance of protecting privacy of any Schedule F or income documents provided to County if income is considered as a prerequisite or threshold for allowed agritourism uses.
- It is not in the scope of CAG to determine:
  - o an income threshold for agritourism eligibility
  - An exact frequency of events to comply with 'temporary'. A general recommendation on a framework for determining intensity (# people/size of event + frequency) would be a more appropriate and useful recommendation to the County
- June 17 will be a voting meeting. We will attempt to reach consensus on as many remand topics as we can and ensure that clear steps are in place to reach consensus (as possible on any remaining items on June 26).
