Guemes Ferry Weekend Update

Transition to Stripe Payment Processor

The ferry division will be transitioning our payment processor for ticket purchasing from LexisNexis to Stripe starting October 29th. We will still utilize the same Anchor ticketing system after the change to Stripe. In order to complete the transition, website and mobile app ticket sales will be unavailable on Tuesday, October 28th, starting at 8:00 a.m. You will still be able to purchase tickets in the Anacortes terminal on October 28th. Online and app sales are estimated to resume by Wednesday, October 29th, at 8:00 a.m.

If you are planning to ride the ferry on Tuesday, October 28th, we highly recommend you buy your tickets in advance to ensure you save time at the terminal. Any unused tickets purchased before October 28th will still be valid and can be used before, during, and after the transition, regardless of how you originally purchased them (app, web, inperson).

We have had a few questions this week about the transition:

1. Will I have to download a new ticket app?

No, the ticketing platform (Anchor), which includes the mobile app, is not changing. You will not have to download any new apps.

2. Why are you changing payment processors?

We have heard from our riders that they would like to be able to save their payment information in the app and use Apple / Google pay to make purchasing faster and easier. LexisNexis did not offer these features, but Stripe does! Starting October 29th, these features will be available to everyone on the Anchor app.

3. Will I lose my stored tickets in the app?

No, your previously purchased, and unused, tickets in the app will not be affected by the transition. They will still be in your account after we switch to Stripe.

4. Will my ticket cost more?

No, the cost for ferry tickets will not change due to the transition to Stripe.

5. Can I still buy my tickets in the Anacortes office after the transition?

Yes, in-person ticket sales will remain available after we move to Stripe.

The Commissioners have selected six applicants from Guemes Island and three applicants from Skagit County atlarge. The TAG charter currently states the members of the TAG include five members from Guemes Island and four from Skagit County at-large. The Commissioners will be amending the TAG charter to change the membership requirements on Monday, October 27th, during the weekly consent agenda.

The ferry division has scheduled the first TAG meeting for Monday, November 17th, at 6:00 p.m. in the Anacortes Library. More details on how to join remotely will be shared soon and made available on the ferry replacement webpage.

UPDATED - Anacortes Ferry Phone Line is Still Down

The phone line to the Anacortes ferry office is still down and will remain out of service for a while longer. The ferry division is working with the Central Services department to replace the old phone system in the Anacortes ferry office. Skagit County will be starting a process to replace all phones at the County in early 2026, and to save costs in 2025, the ferry division will not be replacing the ferry office phones until the new phones systems are replaced as part of the county-wide upgrade project.
