Why Deconstruct & Reuse?

Why deconstruct a building? Deconstruction cuts waste and associated disposal costs. However, there are a variety of other benefits.

Generates revenue

Because deconstruction preserves the value of building materials, project teams can sell them. Alternatively, project teams can reuse salvaged materials, thus avoiding the expense of buying new products. In contrast, demolition practices generate expenses in the form of high disposal fees for waste.

Supports Sustainability

Modern demolition practices typically use heavy machinery to demolish buildings. This method can have significant air quality implications, and heavy machinery can damage sensitive areas such as shorelines, stream banks and tree roots. Deconstruction reduces these effects. As a result, the permitting process for deconstruction can be simpler than for demolition.

Improves Safety

Compared to traditional demolition, which uses heavy equipment, deconstruction poses less serious risk of worker injury.

Is Responsive to the Larger Community

Unlike demolition, deconstruction diverts materials from disposal, creates a local source of building supplies and reduces the demand for virgin materials.

Reputation

Firms that establish a reputation for successfully executing deconstruction and reuse projects can market themselves as specialists in a field of generalists. This experience may translate into greater selection of future work.

C&D Tips: Pre-Planning

- Use contractors experienced in C&D materials reuse and recycling initiatives
- Incorporate C&D materials reuse and recycling language in contract specifications

C&D Tips: Planning

- Develop a C&D recycling plan
- Identify materials for recovery
- Identify markets for materials

C&D Tips: Demolition

- Salvage construction materials when possible
- Investigate reuse of recovered material on site
- Link a deconstruction project with a current construction or renovation project to facilitate reuse of salvaged materials
