APPLIANCES/COMPUTERS

JAYCO Environmental, 1-800-414-5072. Will pick up all household appliances for a fee.

Larry's Auto/Truck Parts, Inc., 360-757-7444; Burlington. Accepts all appliances except refrigerators and freezers; compressor units must be professionally removed before drop-off. Company is a permitted tire recycler, scrap metal processor and automobile dismantler.

Rita Street Appliance Recycling, 360-855-2030; Sedro-Woolley. Accepts, repairs, and sells all major appliances except televisions and computer-related electronics. Fees charged for recycling refrigerators, freezers and hot water heaters.

Skagit River Steel & Recycling, 360-757-6096; Burlington. Accepts all major appliances. Fees charged for refrigerators, freezers, air conditioners, televisions, computer-related electronics and microwaves. Call for details.

Computer Source, 360-855-0730, Sedro-Woolley. Takes computer monitors, computer towers, laptops, PDA's, LCD's, and miscellaneous computer hardware and peripherals. Fees depend on type of material. Call for details.

ASPHALT/CONCRETE

For information on crushing/reusing rubble on-site, call the Skagit County Health Department at 360-336-9380.

Concrete Nor'west, 360-757-0055 or 360-757-3121; Burlington. Accepts concrete only; with rebar okay. Tip fee is dependent on size of chunks and amount of rebar. No dirt or garbage.

Martin Marietta Materials, 360-424-3441; Mt. Vernon. Accepts asphalt and concrete under 2' in diameter. No rebar, contaminated mat'l's, septic tank/sewer concrete. Dump trucks only.

Waste Management, 360-757-4068 (1-800-592-9995); Burlington. Provides containers and hauling of asphalt, concrete (with rebar okay). Prefers chunks under 2' in diameter.

T & T Recovery/Lauts, 360-757-4000 or 1-866-732-9256; Burlington. Accepts concrete (some rebar okay) and asphalt chunks under 4' in diameter at drop location. Provides containers and hauling of asphalt, concrete. Call for details.

GENERAL RECYCLERS

Skagit River Steel & Recycling, 360-757-6096; Burlington. Full service recycling processor for all metals, paper, container glass, cardboard, general plastics, newspaper and miscellaneous items. Drop off, container rental and pickup service available.

Waste Management, 360-757-4068 (1-800-592-9995); Burlington. Provides containers and hauling of wood and wood waste, scrap metal, pallets, new sheetrock remnants, cardboard and all types of paper products. Also, commercial tin, aluminum, glass and plastics as well as yard waste. Full line of recycling services — call for complete list.

T & T Recovery/Lauts, 360-757-4000 or 1-866-732-9256; Burlington. Provides drop location, containers and hauling for wood and wood waste, pallets, scrap metal, sheetrock, cardboard, demolition debris and roofing materials.

Burning is OUT, Recycling is IN...

Burning of yard debris and land-clearing debris is no longer allowed in all urban growth areas and the following cities:

- Anacortes
- Burlington
- Concrete
- Hamilton
- LaConner
- Lyman
- Mount Vernon
- Sedro Woolley

In areas where burning is allowed, check on the permit requirements for your area by calling:

What can and cannot be burned under the new rules?

- Where burning is allowed, only natural vegetation may be burned. However, you may use enough paper to start the fire.
- You cannot burn construction or demolition debris, including lumber scraps.
- State law prohibits burning in burn barrels.
- Impacting neighboring properties with smoke, odor or ash is illegal.

PACKING MATERIALS

Mail Box, 360-293-0342; Anacortes. Accepts clean peanuts, bubble wrap and flat styrofoam sheets.

Packaging Store, 360-757-6800; Burlington. Accepts clean PE foam, peanuts, bubble wrap, honeycomb, corrugated corners and moving cartons. Also accepts Styrofoam sheets and some preformed packaging, but no preformed Styrofoam corners or pieces.

Postal & More, 360-428-5848; Mount Vernon. Accepts bagged and clean peanuts, and air cushions.

Postnet Postal, 360-757-3281; Burlington. Accepts clean peanuts, bubble wrap, air cushions and gray foam.

RUBBER PRODUCTS & TIRES

Larry's Auto/Truck Parts, Inc., 360-757-7444; Burlington. Takes tires, conveyor belts and other rubber products (must be made of rubber with no steel attached). Call for details.

WOOD/LAND CLEARING/ORGANICS/CARDBOARD

Stump and tree chipping and removal: look under "Tree Service" in local phone books.

Waste Management, 360-757-4068 (1-800-592-9995); Burlington. Provides containers and hauling for cardboard. Also offers a full line of recycling services, including the collection of yard waste.

Pallet Services, 360-424-8171; Mount Vernon. Accepts drop-off of good or broken pallets in many sizes. Buys some pallets.

Skagit River Steel & Recycling, 360-757-6096; Burlington. Provides only on-site container or on-site pickup of: clean dimensional or sheet wood (OSB, plywood, particle board, etc., fasteners okay). No pressure-treated wood. Buys cardboard at facility.

Skagit Soils, 360-424-0199; Mount Vernon. Accepts for composting: clean yard waste, tree trimmings, grass clippings, and other organics. Accepts for co-gen burning: wood waste, treated lumber. Also accepts sod, dirt, rocks; please keep separate from yard waste. Accepts new sheetrock (no paint or demolition.)

Sunland Bark & Topsoils, 360-293-7188; Anacortes. Accepts large stumps, trees and brush. No grass or weeds.

T & T Recovery/Lauts, 360-757-4000 or 1-866-732-9256; Burlington. Accepts brush, construction debris, pallets, scrap sheetrock, stumps and wood. Also provides drop boxes of 15-43 yards for those materials. Call for details or go to company website at: www.lautenbachind.com.
