NOTICE IS HEREBY GIVEN that the Skagit County Public Works Department invites the submittal of written statements of qualifications from Consultants interested in providing Engineering and Environmental Services for the resurfacing of the bridge deck and other maintenance required for the Bay View-Edison Joe Leary Bridge.

Bay View – Edison Joe Leary Slough Bridge (Deck Overlay) Project #ES31210-5

PROJECT DESCRIPTION

The Bay View-Edison Joe Leary Bridge is located on Bay View-Edison Road at MP 5.81 and is a four span 30 foot wide by 100-foot-long concrete “tee-beam” built in 1955. The construction consists of resurfacing the bridge deck, improve existing drainage discharge points and repair bank protection under the abutments.

The work to be performed by the Consultant consists of preparation of the PS&E for the deck resurfacing and other maintenance on the Bay View–Edison Joe Leary Bridge No. 40029 that includes design of plans, preparation of project specifications in compliance with local, state, and federal requirements, and construction cost estimate (PS&E), environmental planning and permitting. This assignment may be a multi-phase agreement including pre-bid support, owner’s representative during construction, and contract close out.

DISADVANTAGED BUSINESS ENTERPRISE GOAL

Consultants are alerted that this is a federally funded project. No Disadvantaged Business Enterprise (DBE) goals have been established for this phase of the project.

SUBMITTAL

Cover letter accompanying the statement of qualifications required and shall include the following information: Firm name, phone number, and email address; Name of Principal-in-Charge, Project Manager, and Key Personnel. The submittal package shall be limited to one page cover letter and a maximum of five (5) pages of qualifications (single-sided, letter size), stating qualifications.

Submittals will be evaluated and ranked based on the following criteria:

1) Key personnel; 2) Firms experience with WSDOT PS&E and Federal Highway Administration Standards and requirements; 3) Experience as a structural designer and engineer on bridge maintenance projects valued between \$100,000 to \$1 million; 4) Approach to project; 5) Firms experience with environmental planning and permitting process; 6) Ability to meet schedule; 7) Familiarity with relevant codes and standards; 8) Past performance/references; 9) Experience with the latest edition of AASHTO Specifications for Highway Bridge Design. Selection will be made on qualifications submitted. Highest ranking firms will be interviewed.
