**RESOLUTION REJECTING BIDS RECEIVED FOR  
THE BAY VIEW-EDISON JOE LEARY SLOUGH  
BRIDGE (DECK OVERLAY) PROJECT #ES31210-5,  
FEDERAL AID #BHS-L291(002)**

**WHEREAS**, the Board of County Commissioners deems it to be in the best interest of the County to reject all bids for the Bay View-Edison Joe Leary Slough Bridge (Deck Overlay) Project #ES31210-5, Federal Aid #BHS-L291(002); and,

**WHEREAS**, Resolution No. R20230163 was executed on August 21, 2023, approving the maps, plans and specifications and authorizing the Clerk of the Board to issue a Call for Bid for this project; and,

**WHEREAS**, the Notice of Call for Bids was published in the Skagit Valley Herald and in the Daily Journal of Commerce on August 24, August 31, and September 7, 2023; and,

**WHEREAS**, said Notice of Call for Bids was issued with a bid opening date and time of September 18, 2023, at 2:00 p.m. One Addendum was posted for this project.

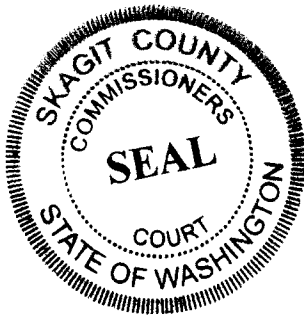
**WHEREAS**, said Bid Opening date and time of September 18, 2023, at 2:00 p.m. resulted Two (2) bids received as follows:

1. Granite Construction Company \$475,356.00  
WSDOT Local Programs, with Office of Equity and Civil Rights concurrence, has determined that the apparent low bidder, Granite Construction Company, is non-responsive on the above referenced contract. The non-responsive determination results from the following:
  - Bid Item #24 on the Bid Item Breakdown (for Finkbonner Flagging) exceeds the bidder's proposal amount by \$698.00.
  - Bid Item #27 on the Bid Item Breakdown (for Red Laser) exceeds the bidder's proposal amount by \$500.00.
2. IMCO General Construction Inc. \$578,817.00  
WSDOT Local Programs, with Office of Equity and Civil Rights concurrence, has determined that the second apparent low bidder, IMCO General Construction, is non-responsive on the above referenced contract. The non-responsive determination results from the following:
  - Bid Item #24 on the Bid Item Breakdown (for Finkbonner Flagging) exceeds the bidder's proposal amount by \$7,680.00.

**WHEREAS**, after further review of the bids, the Office of the County Engineer recommends rejecting all bids received, specifically from Granite Construction Company and IMCO General Construction Inc., as these bids were determined non-responsive per WSDOT Northwest Region, and the Office of Equity and Civil Rights (OECR) as described above.

**NOW, THEREFORE, BE IT RESOLVED AND IT IS HEREBY ORDERED**, that the bids of Granite Construction Company and IMCO General Construction Inc., be and are hereby deemed non-responsive as stipulated herein, and all bids received by the County for the project are hereby rejected.
