Do you Need a Lawyer to Help with your Case?

You May have the Right to an Attorney Paid for by the State if You Are:

Charged with a crime (as an adult or a juvenile)

A Juvenile subject of an At-Risk Youth or Child in Need of Services Petition

A child or parent involved in a dependency or shelter care proceeding
