Meeting called to order at 1:31 PM.

Perkins moves to accept August 11, 2026 canvassing board meeting minutes; D'Avignon seconds. All in favor; none opposed. Motion passes unanimously.

February 10, 2026 Special Election certification meeting minutes reviewed. Wesen moves to approve minutes; D'Avignon seconds. All in favor; none opposed. Motion passes unanimously.

Perkins recites and signs oath that election results are true and correct, later witnessed by D'Avignon and Wesen.

Reconciliation report reviewed by board. Perkins moves to accept reconciliation report; Wesen seconds. All in favor; none opposed. Motion passes unanimously.

Perkins moves to reject challenged ballots; D'Avignon seconds. All in favor; none opposed. Motion passes unanimously.

Perkins moves to accept reports to and certify election; D'Avignon seconds. All in favor; none opposed. Motion passes unanimously.

Clay notes that all certified write-in candidates for Sheriff, Coroner, Treasurer, and Clerk have passed 1% threshold and will appear on November General Election Ballot.

D'Avignon moves to include Cody Hart's letter in meeting record/minutes; Wesen seconds. All in favor; none opposed. Motion passes unanimously.

No further business. No public comments.

Meeting adjourned at 1:43 PM.

Subject: **RE: Overvote counts required to be included in the auditor's abstract of votes — request for confirmation, production, correction going forward, and publication**

Dear Auditor Perkins:

We write as registered voters and electors of Skagit County concerning a single, specific, and readily fixable question: **whether the overvote counts that WAC 434-262-030 requires your abstract of votes to contain are being recorded, retained, and made available to the public.**

I. What this notice asserts, and what it does not

We want to be exact about this, because we think the distinction matters and because we would rather be corrected than be unfair.

We do not assert that you have failed to prepare an abstract of votes. We have searched what Skagit County publishes and we cannot find one. That is not the same thing as its not existing, and we recognize the difference. **The first thing this notice asks is simply whether the document exists.** If it does, and it contains the required overvote counts, then most of what follows falls away and we ask only that it be produced and, going forward, published.

We do not allege that any person has committed any offense. We do not allege that any ballot has been altered, that any result is inaccurate, or that any officer has acted in bad faith. Nothing in this notice should be read as such an allegation, and we ask that it not be characterized as one.

What we do say is that a rule of unusual precision requires certain numbers to be recorded, that those numbers are not publicly available in Skagit County while they are publicly available in neighboring counties, and that a voter is entitled to ask why.

II. The duty to record overvotes

WAC 434-262-030 provides, in full:

County auditor's abstract of votes. The county canvassing board shall meet and canvass all ballots. Upon completion of this canvass ten days after a special election, fourteen days after a primary, and twenty-one days after a general election, the county auditor shall present the auditor's abstract of votes, which must include, at a minimum:

- (1) The number of registered voters eligible to vote in the election, by precinct;
- (2) The number of ballots cast in the election, by precinct;
- (3) The votes cast for each race or issue, including write-ins, undervotes, and overvotes, by precinct;
- (4) Cumulative vote totals including write-ins, undervotes, and overvotes; and
- (5) An aggregate total of votes cast for each declared candidate qualifying for the general election or elected. Individual write-in vote tallies for candidates not meeting the minimum threshold according to chapter 29A.60 RCW shall not be included in the official abstract of votes and results displayed online.

Three features of that rule bear emphasis. It says "**must include.**" It says "**at a minimum.**" And it requires overvotes **twice** — once **by precinct** in subsection (3), and again **cumulatively** in subsection (4).

The same requirement attaches at the preliminary stage. **WAC 434-262-020(1)** provides that "[p]rior to the official canvass, the county auditor shall prepare a preliminary abstract of votes," which "must list separately for each precinct" six items, the last of which is:

- (f) Total number of overvotes and undervotes in each race.

These rules do not stand alone. **RCW 29A.60.230** commands that "[i]mmediately after the official results of a state primary or general election in a county are ascertained, the county auditor or other election officer **shall make an abstract** of the number of registered voters in each precinct and of all the votes cast in the county." **RCW 29A.04.216** provides that "[t]he county auditor of each county shall be ex officio the supervisor of all primaries and elections, general or special." And **RCW 29A.04.611** directs the Secretary of State to adopt rules "to facilitate the execution of [Title 29A's] provisions in an orderly, timely, and uniform manner," expressly including "(9) Standards and procedures to ensure the accurate tabulation and canvassing of ballots" and "(10) **Consistency among the counties of the state** in the preparation of ballots, the operation of vote tallying systems, and the canvassing of primaries and elections." WAC 434-262-030 was adopted under that grant.

We note what the rule does **not** do. It does not ask the auditor to exercise judgment about whether overvote counts are useful, or interesting, or worth the trouble. It states a content requirement with a precision that leaves nothing to discretion.

III. The abstract is part of what the Canvassing Board certifies

This is why the question is not merely clerical.

WAC 434-262-070(2) provides that "[t]he official county canvass report shall include: (a) The certification; (b) **The auditor's abstract of votes as described in WAC 434-262-030.** . . . The vote totals therein shall constitute the official returns of that primary or election."

WAC 434-262-070(1)(a) requires the Canvassing Board to sign a certification stating that "**the abstract is a full, true, and correct representation of the votes cast**" for the offices and measures listed on it. And **RCW 29A.60.200(1)** provides that before canvassing, "the chair of the county legislative authority or the chair's designee shall administer an oath to the county auditor or the auditor's designee **attesting to the authenticity of the information presented to the canvassing board.**"

We want to be careful here, and we ask you to read this paragraph as carefully as we wrote it. We are not suggesting that anyone has sworn falsely, or that any certification was made in bad faith, or that any officer knew of any deficiency. We say only this: a certification speaks to the document being certified. If the abstract that is certified omits an element the rule requires it to contain, the certification does not supply what is missing. That is a reason to get the document right, not a reason to accuse anyone of anything.

IV. What Skagit County publishes, and what neighboring counties publish

Your office's online election archive publishes, for each election, a voters' pamphlet, a sample ballot, a notice of the logic and accuracy test, certification documents, canvassing board agendas and minutes, and a link to results hosted by the Secretary of State.

We have reviewed the "**2024-11-05 Certification Documents**" file. It contains the ballot reconciliation form required by RCW 29A.60.235 — general information, category reconciliation, ballots accepted, overall ballot reconciliation, and an explanation of a VoteWA discrepancy. **It does not contain an abstract of votes, and it contains no overvote count.** The Secretary of State's results portal reports candidate names, vote counts and percentages; we retrieved the underlying county data export directly and its fields are race, candidate, party, votes, percentage and jurisdiction. **There is no overvote field.**

By contrast, and on official county websites requiring no records request:

- **Clallam County** publishes an "**Official Abstract Report**" for the November 2024 general election in which every precinct in every contest carries an "**Over Votes**" column alongside "Under Votes." That document is what WAC 434-262-030(3) compliance looks like in practice.
- **Chelan County** publishes a cumulative results report showing "Overvotes:" for each contest.
- **Kitsap County** publishes a cumulative report showing "Overvotes:" for each contest, and its February 2026 special election canvass reports overvotes **by precinct**.
- **Snohomish County** publishes official results showing "Overvotes" and "Undervotes" for each contest.

We are not suggesting Skagit County is obliged to imitate its neighbors. We raise the comparison for a narrower purpose: it establishes that reporting overvotes is ordinary, that the tabulation systems produce the figure without difficulty, and that publishing it costs a county essentially nothing.

And again — the absence of these figures from your website does not establish that the abstract was never prepared. That is precisely what Demand 1 below asks.

V. These records may not lawfully be destroyed

Because part of what we ask concerns past elections, we set out the retention position plainly.

The **Washington State Archives County Auditors Records Retention Schedule, Version 6.0 (August 2025)** governs. Disposition Authority Numbers **AU52-03C-74** ("Election – Official Results Records – Federal") and **AU52-03C-75** ("Election – Official Results Records – Non-

Federal") both list, among the records they cover, "**Official abstracts of the votes that were tabulated.**" The disposition for both is not destruction:

Retain for 22 months after date of election then Transfer to Washington State Archives for permanent retention. [AU52-03C-74]

Retain for 60 days after date of certification then Transfer to Washington State Archives for permanent retention. [AU52-03C-75]

Both series are **ARCHIVAL — permanent retention**. And **RCW 40.14.070(2)(a)** provides that "no public records shall be destroyed until approved for destruction by the local records committee." The committee has approved transfer, not destruction.

We anticipate that **WAC 434-262-200** may be raised in response. It provides that "[a]ll records and materials are to be maintained for a period of sixty days after certification of each election. Where the election involves federal offices the records and material must be kept for twenty-two months from the date of the election." That rule sets a **minimum holding period**. It is not authority to destroy a record the approved retention schedule designates archival, and reading it that way would put the County in conflict with RCW 40.14.070.

The consequence is straightforward: for every past election, the abstract of votes either exists, or has been transferred to the State Archives, or its absence is itself something the County should be able to explain.

VI. What we ask you to do

- **1. Confirm, in writing, whether an abstract of votes complying with WAC 434-262-030 — including overvote counts by precinct under subsection (3) and cumulatively under subsection (4) — was prepared for each of the following elections:** the primary and general elections of 2020, 2021, 2022, 2023, 2024, and 2025; and the primary election of August 4, 2026, upon its certification. A simple yes or no for each election is a complete answer to this demand.
- **2. Produce each such abstract** that exists, in native electronic format (Excel or CSV where available, rather than a scanned or printed PDF).
- **3. For any election in which the abstract does not contain the overvote counts required by WAC 434-262-030(3) and (4), state that fact and explain why,** and state whether the underlying data remains available in the tabulation system such that a compliant abstract can now be produced. If it can be, we ask that it be produced.
- **4. Going forward, include overvote counts in both the preliminary abstract required by WAC 434-262-020(1)(f) and the auditor's abstract required by WAC 434-262-030(3) and (4),** beginning with the August 4, 2026 primary and continuing for the November 3, 2026 general election and thereafter.
- **5. Publish the abstract of votes, including its overvote and undervote columns, with your published election results,** as Clallam, Chelan, Kitsap and Snohomish counties do.

See Part VII below, in which we are candid that this particular request is not one we contend any rule compels.

- **6. Confirm the retention and archival status** of the abstract of votes for each election listed in Demand 1 — whether it is held by the County, whether it has been transferred to the Washington State Archives, and if any has been destroyed, the date and the authority relied upon.
- **7. Present this notice to the Skagit County Canvassing Board** at its ballot review meeting of August 11, 2026 and its certification meeting of August 18, 2026, and ask that it be entered in the minutes of each.
- **8. Preserve** all records relating to the subject matter of this notice, including tabulation system reports, abstracts, canvass reports, and the resolution logs required by WAC 434-261-102 and duplication logs required by WAC 434-261-100(1)(b).

We request a written response by 5:00 p.m. on Tuesday, August 18, 2026, the date the Canvassing Board is scheduled to certify the August 4 primary.

To the extent any part of this notice constitutes a request for identifiable public records, it is made under chapter 42.56 RCW, and RCW 42.56.520 requires a response within five business days.

VII. A candid statement of what the law does and does not require

We would rather tell you the weak part of our own position than have you discover it.

We have not found any statute or rule that expressly requires a county auditor to publish the abstract of votes. The publication command in this area runs to a different document: **RCW 29A.60.235(2)** requires that the ballot reconciliation report be made "available to the public at the auditor's office" and "publish[ed] . . . on the auditor's website at the time of certification" — and the enumerated contents of that report do not include overvotes.

So **Demand 5 is a request, not an assertion of legal obligation.** We make it because four neighboring counties do it, because it costs nothing, and because it would answer permanently a question that voters will otherwise keep asking. Demands 1, 2, 3, 4, 6, 7 and 8 stand on different footing: they rest on a mandatory content requirement, on the Public Records Act, and on an approved retention schedule.

We also acknowledge a limit on precinct-level reporting that we are not asking you to disregard. **WAC 434-262-020(2)** and **RCW 29A.60.230** provide for aggregating precincts where reporting separately would compromise ballot secrecy. Clallam County's Official Abstract Report applies exactly that rule on its face, combining a nine-voter precinct split with a neighboring precinct.

We are not asking for anything that would compromise the secrecy of any ballot, and we would expect any compliant abstract to apply that aggregation.

VIII. If we receive no response

We would much rather this be resolved by a letter from your office than by anything else, and we expect that it will be. But we would not be candid if we left our intentions unstated.

Washington law provides that a writ of mandamus "may be issued by any court . . . to any inferior tribunal, corporation, board or person, **to compel the performance of an act which the law especially enjoins as a duty resulting from an office, trust or station.**" RCW 7.16.160. It "must be issued in all cases where there is not a plain, speedy and adequate remedy in the ordinary course of law," "upon affidavit on the application of the party beneficially interested." RCW 7.16.170. An applicant must show three things: that the party subject to the writ "is under a clear duty to act"; that the applicant has no plain, speedy and adequate remedy at law; and that the applicant is beneficially interested. *Eugster v. City of Spokane*, 118 Wn. App. 383, 402-03, 76 P.3d 741 (2003).

Mandamus lies only for a ministerial duty — one where "the law prescribes and defines the duty to be performed with such precision and certainty as to leave nothing to the exercise of discretion or judgment." *SEIU Healthcare 775NW v. Gregoire*, 168 Wn.2d 593, 599, 229 P.3d 774 (2010). "The mandate must specify the precise thing to be done or prohibited." *Freeman v. Gregoire*, 171 Wn.2d 316, 323, 256 P.3d 264 (2011).

We think a rule providing that the abstract "**must include, at a minimum . . . (3) The votes cast for each race or issue, including write-ins, undervotes, and overvotes, by precinct**" is about as precise a specification of the thing to be done as election law contains. We recognize you may see it differently, and if you do we would genuinely like to understand why — which is what Demand 3 asks.

We have separately filed a complaint with the Secretary of State under **RCW 29A.04.570(1)(b)**, which permits any resident who "believes that an aspect of a primary or election has been conducted inappropriately in a county" to do so.

IX. What would resolve this

If your office confirms that compliant abstracts exist, produces them, and states that overvote counts will be included and published going forward, we will consider this matter closed and will say so publicly. We are not seeking a controversy. We are seeking a column of numbers that a rule already requires you to record.

DECLARATION OF JOAN BURNS

**In the Matter of: SKAGIT COUNTY AUGUST 2026 PRIMARY ELECTION — COUNTY
ELECTION WORKER BALLOT HANDLING SECURITY AND OBSERVATIONS**

I, Joan Burns, declare as follows:

1. I am over the age of eighteen years, am competent to testify to the matters stated in this declaration, and make this declaration on my own personal knowledge.
2. I am a registered voter and elector of Skagit County, Washington. My address is 15484 Ginthner Drive, Mount Vernon, WA 98273.
3. I am a credentialed election observer for the Skagit County primary election held August 4, 2026. I was appointed as an observer by the Skagit County Republican Party. I understand that election observers are provided for by RCW 29A.40.100 and WAC 434-261-020, that an observer may not touch any ballot, and that an observer may not disrupt ballot processing.
4. At no time during any observation described in this declaration did I touch any ballot, ballot container, or election equipment, photograph any voted ballot, or interfere with ballot processing in any way.
5. On Friday, July 24, 2026, beginning at approximately 10:45 a.m. and continuing for approximately 1 hours 45 minutes, I observed ballot processing at the Skagit County Elections office located at 700 S. Second Street, Room 139, Mount Vernon, Washington.
6. Where I use the term "vote target area" in this declaration, I mean the printed oval, box, or similar marking area on a ballot that a voter fills in or marks to indicate a choice.

7. During that observation I saw one Skagit County election worker handling ballots while wearing rubber gloves and rubber fingertip coverings that I understand are commonly called finger cots.

8. On more than one occasion, I saw a female worker gloved or finger-cot-covered fingertip come into direct contact with the vote target area of a ballot.

The female worker would point and tap on the ballot target area.

9. At the times I observed this contact, the worker was not performing ballot duplication.

The female worker was at a general ballot stacking table with three other workers forming stack of ballots, no ballot duplication was occurring.

10. I did not ask anyone at the time why an election worker would make contact with the vote target area of a ballot.

11. No one has explained to me why a Skagit County election worker would make contact with the vote target area of a ballot outside of the ballot duplication process.

12. Also during my observation on July 24, 2026, I overheard one Skagit County election worker state that they sometimes bring their own rubber gloves from home to use in the county election office during ballot processing.

I location of the worker that I overheard was in the Election office for Skagit County at 700 S. Second Street, Room 139, Mount Vernon, WA.

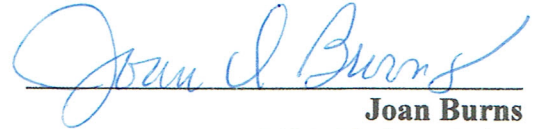
13. I do not know whether any ballot was altered, and I do not claim that any ballot was altered. I state in this declaration only what I saw and what I heard. I express no opinion as to the intent of any person or as to the accuracy of any election result.

15. I am willing to be interviewed about these observations by the Skagit County Prosecuting Attorney, the Washington Secretary of State, the Washington Attorney General, or any federal authority, and to answer questions under oath.

Subject: **URGENT preservation demand concerning surveillance recordings of July 24, 2026; and request for public records concerning protective handwear and ballot-handling controls**

Dear Ms. Herman and Auditor Perkins:

PART I — URGENT DEMAND TO PRESERVE

The specific recordings at issue

We enclose the **Declaration of Joan Burns**, a credentialed election observer appointed by the Skagit County Republican Party for the August 4, 2026 primary. Ms. Burns states under penalty of perjury that on **Friday, July 24, 2026, beginning at approximately 11:00 a.m.**, during ballot processing at **700 S. Second Street, Room 139**, she observed a Skagit County election worker wearing rubber gloves and finger cots make direct contact with the **vote target areas** of ballots, at a time when that worker was **not performing ballot duplication**. She further states that she overheard county election workers say that they sometimes **bring their own rubber gloves from home** for use during ballot processing.

We do not allege that any ballot was altered. Ms. Burns does not allege it either. We say only that specific conduct was observed on a specific date at a specific time, that no one has explained it, and that if a recording of that period exists it will show what actually happened far better than anyone's recollection. Preserving it protects the County at least as much as it protects us.

What must be preserved immediately

- 1. All video surveillance recordings covering Room 139 at 700 S. Second Street, and any other area in which unsecured ballots were present, for Friday, July 24, 2026, from 8:00 a.m. through 5:00 p.m.** We ask that a copy be exported to separate, non-overwriting media **today or as soon as practicable**, and that the County confirm in writing that this has been done. Surveillance systems commonly overwrite on a 30- to 90-day cycle, and July 24 is already ten days past.
- 2. All video surveillance recordings** of the same areas for the period **July 1, 2026 through certification of the August 4, 2026 primary.**
- 3. The retention schedule, configuration, and overwrite interval** of the surveillance system serving the ballot processing and storage areas, together with the identity of the person or vendor who administers it.
- 4. All observer sign-in logs, observer rosters, and observer credential records** for July 1, 2026 through August 4, 2026, including all records reflecting Ms. Burns's presence on July 24, 2026.
- 5. All staffing schedules, station assignments, sign-in sheets, badge and keycard access records, and timesheets** identifying every person present in or admitted to the ballot processing area on **July 24, 2026.**
- 6. All voted ballots, ballot envelopes, ballot images, seal logs, secure-storage access logs, chain-of-custody records, ballot transfer records, and ballot accountability and reconciliation reports** for the August 4, 2026 primary.

7. All **incident reports, notes, internal communications, text messages, and email** concerning ballot processing on July 24, 2026, or concerning any question raised about the handling of ballots on that date.
8. Any gloves, finger cots, or other protective handwear remaining in the County's possession that were procured for or used in connection with the August 4, 2026 primary.
9. All records described in Part II below.

The legal basis

Skagit County lies entirely within **Washington's 2nd Congressional District**, and the office of **United States Representative** appeared on the August 4, 2026 primary ballot. **52 U.S.C. § 20701** therefore requires every officer of election to "retain and preserve, for a period of twenty-two months from the date of any" such election, "all records and papers which come into his possession relating to any application, registration, payment of poll tax, or other act requisite to voting in such election." Willful failure to comply is a federal criminal offense, and the Attorney General may compel compliance under 52 U.S.C. §§ 20703 and 20704. That period runs through approximately **June 4, 2028**. Independently, **RCW 29A.60.110(1)** requires retention of counted ballots for "at least sixty days or according to federal law, whichever is longer."

This letter also constitutes notice that the materials listed above are reasonably likely to be relevant to anticipated proceedings, and we ask that any routine destruction, recycling, overwriting, or automatic deletion affecting them be suspended immediately.

We request written confirmation, by 5:00 p.m. Wednesday, August 5, 2026, that the July 24, 2026 recordings described in item 1 have been preserved. We recognize this is a short timeline; it is short because the risk is loss, not because we wish to be difficult.

Under RCW 42.56.080 we are not required to state a purpose for this request and the County may not condition disclosure on one. We request copies of the following. Where a category is broad we are glad to narrow it — please contact us rather than denying on that basis.

- 2. All records reflecting the **procurement** of such handwear for the Elections Division from January 1, 2022 to the present, including purchase orders, requisitions, invoices, packing slips, and quantities ordered and received.
- 3. All records reflecting the **issuance, distribution, inventory, tracking, reconciliation, or return** of such handwear to or from election workers, staff, temporary employees, or volunteers.
- 4. All records governing or reflecting the **inspection, storage, disposal, or destruction** of such handwear.
- 5. All written policies or rules governing **what personal items any person may bring into, possess within, or remove from the ballot processing area**, including bags, containers, writing instruments, electronic devices, and **personally supplied handwear**.
- 6. Records sufficient to show whether the County **permits election workers to use protective handwear they supply themselves**, and any written or oral guidance given to workers on that subject.
- 7. All records reflecting the circumstances in which an election worker is **authorized to make physical contact with the vote target area of a ballot**, and all training on that subject.
- 8. The **administrative rules adopted by the Skagit County Canvassing Board** under RCW 29A.60.140(4), as currently in effect and as in effect for each primary and general election from January 1, 2022 to the present.
- 9. The **written rules for observers** provided under WAC 434-261-020, and the **written ballot-duplication procedures** required by WAC 434-261-100(2), including the county canvassing board manual containing them.
- 10. The **audit-trail documentation** required by WAC 434-250-130 for the August 4, 2026 primary, including documentation of "the security procedures undertaken to protect the integrity of all ballots after receipt, including the seal numbers used to secure the ballots."
- 11. All **seal logs, secure-storage access logs, ballot transfer records, and chain-of-custody records** for the August 4, 2026 primary, including those required by WAC 434-261-045.

- **15.** The current **organizational chart or staff roster** of the Elections Division sufficient to identify the position and title of each employee, including the employee identified to us as "Collette."
- **16.** Any policy, procedure, directive, or written communication **created, revised, or circulated on or after July 24, 2026** concerning protective handwear or the physical security of ballots during processing.

Format, fees, installments, and response

We request electronic copies via the portal or by email. Please provide an itemized fee estimate before incurring costs; we authorize up to **\$20.00** without further approval. If records are voluminous we request installment production under RCW 42.56.080(2), beginning with categories 1, 5, 6, 7 and 16.

RCW 42.56.520 requires a response within **five business days** — no later than **Monday, August 10, 2026**. If any record is withheld in whole or part, RCW 42.56.210(3) requires a statement of the specific exemption and a brief explanation of how it applies; please provide a withholding log rather than a categorical denial.

We would prefer to resolve any dispute informally and are available by phone or in person. We note only, for completeness, that RCW 42.56.550 provides de novo review, places the burden on the agency, and authorizes costs, reasonable attorney fees, and a penalty of up to \$100 per day to a prevailing requestor.

Reservation

Nothing in this letter alleges that any person has committed any offense, and we make no such allegation. We reserve all rights.
